Broken Hearts

"It has been devastating and heartbreaking to hear in the news that the remains of 215 children buried in unmarked graves have been found on the Kamloops Indian Residential School grounds."

Thus begins the letter from the bishops of the ELCIC with a renewed call for reconciliation. The entire letter can be found in this newsletter, beginning on page 5. Although many non-Indigenous people were shocked by such news, it was common knowledge for decades among Indigenous people about such burial sites and undocumented graves.

Canadian history has whitewashed what happened to Indigenous people for centuries, so it is imperative for those of us who are "settlers," and especially those of us who claim to be Christians, to become educated. The exploitation of Indigenous people and their lands began with Papal Bulls (or decrees) of the 15th century which gave Christian explorers the right to claim lands they "discovered" and lay claim to those lands for their Christian



monarchs. Any land that was not inhabited by Christians was considered "empty" and deemed available to be "discovered", claimed, and exploited. Such lands included the Americas and Africa. Residential schools

and the Indian Act in Canada, as well as legislation in other countries perpetuated this notion of sovereignty and white supremacy. As Christians we have so much to learn, to repent of, before we can truly begin to work towards healing and reconciliation with Indigenous people. 

A Renewed Call to Reconciliation

It has been devastating and heartbreaking to hear in the news that the remains of 215 children buried in unmarked graves have been found on the Kamloops Indian Residential School grounds.

We invite all members across the ELCIC to join us in offering our heartfelt empathy and prayers for the families of those children, for the Tk'emlúps te Secwépemc First Nation, for the City of Kamloops and for First Nations Communities across Canada as they grieve this loss. Let us offer solidarity, support and care to all who are feeling grief, anger, trauma and the need for healing. Please join us in praying for comfort and peace.

News about undocumented deaths of our nation's Indigenous children is tragic. Yet, as Richard Jock, CEO of the First Nations Health Authority (FNHA) said, "[it] is sadly not a surprise and illustrates the damaging and lasting impacts that the residential school system continues to have on First Nations people, their families and communities." This is further proof of the sinful and abusive legacy of these schools — schools in which the church and government were active participants.

The remains of these children show us the depth of our systemic racism and the lengths that the dominant culture was willing to go in order to destroy another culture. Many of us can connect our ancestors to the history of the dominant culture. Knowledge of this cruel history is something that demands our repentance, but also asks us to faithfully work for a better and different future.

We name today the devastating and ongoing cultural, emotional, and spiritual impact that residential schools continue to have on Indigenous peoples

In 2011, the ELCIC made a commitment to promote right and renewed relationships between nonindigenous and Indigenous Peoples within Canada. In 2015, the ELCIC repudiated the *Doctrine of Discovery*. We committed ourselves to seek greater understanding of the issues facing Indigenous peoples, and to walk with Indigenous peoples in their ongoing efforts to exercise their inherent sovereignty and fundamental human rights.

We call on all members of the ELCIC to re-engage in the work of reconciliation to which we have been called in baptism. This means educating ourselves on our history and understanding. It means listening to the voices that are often marginalized or silenced in our conversations.

It also means insisting on accountability. Talk with your government representatives and encourage ther to follow through on recommendations #71-#76 of the Truth and Reconciliation Commission of Canada (TRC) Calls to Action dealing specifically with Missing Children and Burial Information. Talk with you pastor, your deacon and your faith community about responding to Calls to Action #59-#61 in your conte

Release, Waiver of Liability, and Assumption of Risk Agreement Relating to COVID-19

(BY SIGNING THIS DOCUMENT, YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. PLEASE READ CAREFULLY!)

In consideration of Mount Zion Lutheran Church of New Westminster (the "Congregation") permitting me access onto its property and premises at 930 Cumberland Street, New Westminster (the "Property") for the purpose of worship, meetings, gatherings and other events

I ACKNOWLEDGE AND AGREE AS FOLLOWS:

I have been made aware that and acknowledge:

- The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is contagious and is believed to spread mainly from person-to-person contact. As a result, federal, provincial, and local governments and federal and provincial health agencies recommend physical distancing and have, in many locations, prohibited the congregation of mass groups of people.
- The risks of COVID-19 are not fully understood, and contact with, or transmission of, COVID-19 may result in risks including but not limited to personal injury, illness, permanent disability, death, damage, loss, and expense, the exact nature of which are not currently ascertainable.
- The Congregation has put in place preventative measures to reduce the spread of COVID-19 at the Property; however, the Congregation is not responsible in any manner for any risks related to COVID-19 or if my family members or I develop COVID-19 or symptoms of COVID-19.
- Attendance at the Property carries with it certain inherent risks related to COVID-19 transmission that
 cannot be eliminated regardless of the care taken to avoid such risks. Inherent risks may include, but are
 not limited to: (1) the risk of coming into close contact with individuals or objects that may be carrying
 COVID-19; (2) the risk of transmitting or contracting COVID-19, directly or indirectly, to or from other
 individuals; and (3) injuries and complications ranging in severity from minor to catastrophic, including
 death, resulting directly or indirectly from COVID-19 or its treatment.
- By attending the Property, I could increase my risk and my family's risk of contracting COVID-19.

I voluntarily accept and assume the risk that I may be exposed to or infected by COVID-19 by attending the Property and that such exposure or infection may result in personal injury, illness, permanent disability, death, damage, loss, and expense.

I understand that the risk of becoming exposed to or infected by COVID-19 at the Property may result from the actions, omissions, negligence, breach of contract, or breach of statutory duty of myself and others, including, but not limited to the Congregation, the BC Synod of the Evangelical Lutheran Church in Canada (the "Synod"), and the Congregation's and Synod's respective directors, officers, managers, employees, agents, servants, representatives, and contractors (collectively the "Lutheran Parties").

I agree, on behalf of myself, my heirs, executors, administrators, and assigns to hereby release, waive, discharge, and covenant not to sue the Lutheran Parties from any and all causes of action, claims, demands, liabilities, requests, damages or any recourse whatsoever that I now have or may have in the future, in respect of any personal injuries or other damages which may occur or arise as a result of exposure to COVID-19 during my visit to the Property, whether caused by the negligence, breach of contract, or breach of statutory duty of care of the Lutheran Parties or otherwise.

I will abide by the Congregation's safety and COVID-19 guidelines at all times while I am on the Property and will follow and comply with the instructions of the Congregation's leaders, employees, and volunteers with respect to COVID-19 precautions;

I represent and warrant that I do not have symptoms of COVID-19, have not been diagnosed with COVID-19, am not awaiting the results for a COVID-19 diagnostic test, have not been in close contact with or have a household member with COVID-19, and have not travelled internationally within the last 14 days. If any of these conditions apply to me, I will not enter the Property;

I understand that this permission to attend at the Property may be revoked at any time by a Congregation representative for failure to comply with COVID-19 safety guidelines and, if revoked, I agree to leave the Property immediately;

I agree that this Release, Waiver of Liability and Assumption of Risk Agreement extends to all acts of negligence by the Lutheran Parties, whether a COVID-19 infection occurs before, during, or after my attendance at the Property, and is intended to be as broad and inclusive as is permitted by the laws of British Columbia and that if any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect.

I have read this Release, Waiver of Liability and Assumption of Risk Agreement, fully understand its terms, understand that I have given up substantial legal rights against the Lutheran Parties by signing it, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me. I intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
