6 months

Milestones

We now have passed the six-month milestone since we closed the doors of Mount Zion to in-person worship and gatherings. At that time we thought we may return to "normal" by September. Well, September has come and gone, and we are now looking at possibly some time in 2021.

However, thanks to a reminder about celebrating our 125th anniversary four years ago, I realized that this is NOT the first time in our history to have weathered a global pandemic. Mount Zion (then known as Nidaros) survived the Spanish Flu Pandemic which began in 1918. "A *Province* article from Oct. 16, 1918 claims 'Royal City to be Closed Up Tight.' The article goes on: "Schools, theatres, churches, and all public meetings will be closed and semi-public functions, such as dances and whist drives, will also be forbidden. The rapid spread of Spanish 'flu' has caused this drastic order." (<https://www.mapleridgenews.com/opinion/looking-back-quarantine-back-in-the-day-of-the-spanish-flu-kept-maple-ridge-safe/>)

The restrictions imposed over a hundred years ago sound very familiar. Yet we keep hearing how we are living in unprecedented times. As rates of COVID-19 infection rise, as we learn more about the lingering effects for those who have been ill, I am sure many of us think we are living in historical times, that we will tell future generations engaging stories about surviving a pandemic.

Yes, these times are reminiscent of the 1918 pandemic. Much to my surprise, a quick check of the history book prepared for Mount Zion's 100th Anniversary yields NO reference to the Spanish Flu. It mentions the two World Wars, the hard times after 1920, but NOTHING about the Spanish Flu! Instead they refer to God's faithfulness through the difficult and simpler times. The God who was with this congregation in 1918 is the same God who is with us now in 2020. So, whether we have another 6, 9, 12 or who knows however many more months to go, take a look at the mountains and take comfort from these words written long, long ago in Psalm 121:

I lift up my eyes to the hills—from where will my help come?
My help comes from the LORD, who made heaven and earth.
He will not let your foot be moved; he who keeps you will not slumber.
He who keeps Israel will neither slumber nor sleep.
The LORD is your keeper; the LORD is your shade at your right hand.
The sun shall not strike you by day, nor the moon by night.
The LORD will keep you from all evil; he will keep your life.
The LORD will keep your going out and your coming in from this time on and forevermore.

Our Duty to Care

Several months ago, the BC Synod contacted a lawyer to get a legal opinion on three questions:

1. What would the church’s liability be if a member of a congregation, an employee or a visitor died as a result of COVID-19?
2. What steps should a congregation take to avoid the risk of liability for COVID-19 transmission?
3. Will the church's insurance coverage apply if a COVID-19 claim was made against a congregation?

Here are some highlights from the lawyer’s response to these questions.

As an owner Mount Zion Lutheran Church has a “duty to care” for people who are in our building and on our property. As a result, we are at risk of liability if a person becomes ill and dies after contacting COVID-19 (presuming proof that the virus was transmitted on church property). This duty to care for people includes employees, visitors, and visitors who enter our church under a rental agreement.

Congregations can manage their risk with the following: comply with government orders; implement the BC Synod’s reopening guidelines; monitor and enforce compliance; and remain current with COVID-19 updated practices and procedures. *(Please note that the provincial government recently enacted a regulation that protects faith-based organizations against liability so long as it can demonstrate that it has complied by public health guidelines. It will not protect organizations if there is gross negligence.)*

The letter includes three additional suggestions that congregations can do to protect against liability. First, everyone entering the church must sign a release and waiver agreement (a sample letter was provided). Secondly, renters are required to indemnify our congregation in the event of renter’s negligence or breach of contract (we were given sample wording to use). Furthermore, congregations

should confirm COVID-19 coverage with their insurance broker.

The lawyer concluded his letter to the BC Synod with a list of 17 recommendations for congregations. We will review three in each of the upcoming newsletters along with what we are doing to comply. Here are the first three recommendations:

Recommendation #1: Create a COVID-19 leadership team

Council created a COVID-19 Task Force at the end of June and this Task Force has been meeting almost weekly since the beginning of July. The Task Force created a written “Safety Plan for Employees,” using the format of WorkSafeBC and following the guidelines of CDC and provincial health guidelines. (This safety plan is posted on our website.) The Task Force reviews all requests to use church property. More recently, we are creating an action plan to implement all 17 of the lawyer's recommendations to protect against liability.

Recommendation #2: Implement procedures for waiver and release agreement

On September 27, 2020 Council passed a motion that all those who attend in-person gatherings will be required to sign a “Release, Waiver of Liability, and Assumption of Risk Agreement Related to COVID-19”. A copy of this form can be found in this newsletter. The COVID-19 Task Force developed a communication plan (newsletter, website), and a plan for monitoring compliance.

Recommendation #3: Include indemnity language in the written rental agreements

The Task Force implemented an immediate plan to include the indemnity clause in our rental agreements. This language will be included in all rental agreements effective October 1, 2020.




